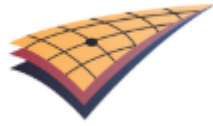

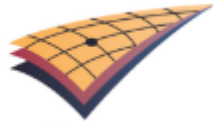

- What went well - along the lines of staffing, data, systems, standards, access etc.
- What were your challenges
- What will be worked on next to improve;

3. Please come to the meeting with a couple of maps/photos - or if comfortable shapefile/gdb of incident.

Information will be captured at the meeting, and then the storymap developed prior to AFAC in Brisbane.
